I realize that these risks cannot be eliminated and include, but are not limited to, falling into the water, being struck by equipment or a boat, drowning, and being struck by others. These risks may be caused by the negligence of myself or others, reckless misconduct by myself or others, or otherwise.

I understand and acknowledge that these risks could lead to severe physical and/or emotional injury, paralysis, death, and/or damage to me, property belonging to me, Leesburg Wakeboarding ("LW"), and/or to third parties. My participation in the watersports activities is voluntary, and I agree to assume all risk of personal injury, including paralysis and death, which may occur while I am at/on any LW facility or participating in any watersports activity.

I agree to abide by all LW safety rules and strictly follow all instructions given and requests made by LW and its employees I agree to use proper water ski, wakeboard, wake skate, sky ski, wake surf, kneeboard, inner tube, swimming and passenger in a powerboat practices and/or procedures, and further agree that if I fail to follow proper procedures, the fault is solely mine. Finally, I agree to pay attention to the lake and/or river and the boat equipment, and to advise LW if I inflict or notice any damage.
